"I am grateful to Amara for the opportunities it has provided for me to grow both professionally and personally, and I look forward to continuing our relationship in this new role."




We're Hiring for a Virginia Staff Attorney & Policy Counsel

legal advice, advocacy, and representation on civil and criminal cases in Virginia state courts including, but not limited to: criminal record expungement, civil protection orders, child custody, divorce, name changes, criminal defense, and victim-witness advocacy.



This position also works collaboratively with the Chief Executive Officer, staff and Board, and other stakeholders, to establish the policy priorities for DC, Virginia and the federal level that are consistent with the goals of Amara's strategic plan. Although Amara's staff work remotely, the Virginia Staff Attorney & Policy Counsel must be able to travel to Virginia courts and meetings in the DC-metro area.
