# Client Success Story

An Amara staff attorney assisted a client with Victim-Witness Advocacy because her trafficker/abuser violated a civil protective order (CPO) that was entered in Maryland. In the course of the representation, the attorney discovered that the opposing party had never been served with the CPO



and so it was void. This would mean that the opposing party could not be found guilty of the violation.



However, Amara's attorney worked with the prosecutor to secure the client a new CPO in lieu of prosecution. The judge granted a new, two-year protective order against the opposing party which was served on him. Now, he can have no contact with the client directly or through a third party and must stay 100 yards away from her at all times. Our client now feels safe.
